PARTICULAR CONDITIONS OF THE CONTRACT

- 1) The work has to be conducted in the presence of Departmental Engineers or his representatives at SCC Campus, ISTRAC, Peenya, Bengaluru.
- 2) The water will be supplied by the Department free of cost near the place of testing.
- 3) All Security regulations prevailing at the campus shall be adhered to. The work force personnel deployed by the agency shall produce ID proof for entry into the campus.
- 4) The period of completion shall be 15days from day of issue of work order.
- 5) The agency shall visit the site and ascertain the site condition before quoting/commencing the work.
- 6) IT as applicable shall be deducted from the bill and a certificate of IT deduction made will be issued.
